A motion was made to reimburse the pastor for funds he had personally given to a person requesting financial aid in December of 2013. The motion was seconded and approved.

With the opening of a new section of the cemetery, discussion was held on the addition of a new driveway for cemetery access. A motion was made to add a driveway to the new section creating an area the same size as in the other cemetery section. The motion was seconded and approved.
